Every state has different regulations for home care agencies, and some states still do not regulate home care agencies at all. It is important to verify that your home care agency thoroughly screens their caregivers PRIOR to employment when interviewing home care agencies.

Private duty services are basically any supportive type of services. They run the gamut from errands and transportation, to companionship, to personal care, to nursing. It really can be any type of service that is provided to someone who is frail or elderly to allow that person to have more independence in his or her lifestyle or choice of living situation.
